Reference citations in the text should be identified by numbers in square brackets. Some examples: Negotiation research spans many disciplines [1]. This result was later contradicted by Becker and Seligman [2]. This effect has been studied [1-3, 7]. (Use “body” text style, 10 pt., Times New Roman)

2 Experimental section (Bold, 12 pt., Times New Roman)

Experimental details should be provided in the experimental part, including the raw materials, preparation process, and and process parameters used. Provide sufficient detail to allow the work to

be reproduced. The number of experimental samples should not be too small, and the reliability analysis of data should be carried out when the data dispersion is large. Test methods and types and operating parameters of testing devices/instrument used should be provided in detail. (Use “body” text style, 10 pt., Times New Roman)

3.1 Second-order heading (Bold, 10 pt., Times New Roman)

The results and discussion section should be organized using appropriate sub-headings. Use a normal, plain font for text. Do not use field functions. Use tab stops or other commands for indents, not the space bar. Use the table function, not spreadsheets, to make tables. Use the equation editor or MathType for equations.

Figures and Tables should follow the paragraph where they are first mentioned. For example, SEM images [Figs. 1(a-c)] reveal that this
